01. I understand that as a Rain International Distributor:
  - a. I have the right to offer for sale Rain International products and services in accordance with these Terms and Conditions.
  - b. I have the right to enroll persons in Rain International.
  - c. If qualified, I have the right to earn commissions pursuant to the Rain International Marketing and Compensation Plan.
02. I agree to present the Rain International Marketing and Compensation Plan and Rain International products and services as set forth in official Rain International literature. I agree that I may not re-label, repack, or otherwise alter any Product, nor will I sell any Rain International Product under any other name.
03. I agree that as a Rain International Distributor I am an independent contractor, and not an employee, partner, legal representative, or franchisee of Rain International. Within the framework of the Agreement, I do not take instructions. I am free to plan my business activities, if any. I can choose working hours and preferred sales methods. I agree that I will be solely responsible for paying all expenses incurred by myself, including but not limited to travel, food, lodging, secretarial, office, long distance telephone and other expenses. I UNDERSTAND THAT I SHALL NOT BE TREATED AS AN EMPLOYEE OF RAIN INTERNATIONAL FOR ANY TAX PURPOSES. 04.
